



SIGNATURE QUARTERS, LLC LIMITED WARRANTY

Signature Quarters, LLC warrants that its products will be free from defects in materials and/or workmanship to the original purchaser for a period of three (3) years from the date of purchase providing the conditions are met and satisfied (“Warranty”).

The attached warranty card must be completed and returned to Signature Quarters, LLC, 4322 S. 4th Street, Chickasha, OK 73018. These documents must be filed with Signature Quarters, LLC within thirty (30) days from date of purchase to validate the Warranty. If the signed warranty card is not postmarked by the 30th day after purchase, all express warranties contained in this Warranty are null and void.

This Warranty excludes the following items, which are not manufactured or constructed by Signature Quarters, LLC. These components are warranted by their respective manufacturer with a copy of its warranty for these components provided as attachments to the trailer living quarters user manual:

This Warranty extends only to those materials used or workmanship performed by Signature Quarters, LLC in the construction of the trailer conversions, subject to all limitations and exclusions herein. Signature Quarters, LLC reserves the right to make changes in design or make addition and/or improvements without being obligated to install or modify same upon other products covered by this warranty.

Signature Quarters, LLC EXPRESSLY DISCLAIMS, DOES NOT WARRANT AND EXCLUDES ANY RESPONSIBILITY OR LIABILITY for any materials or workmanship of any items installed, or for structural failure due to modification of Signature Quarters, LLC products, by any other person or company, including incidental, economic, consequential and any other damages or contingent liabilities arising therefrom. Any modification to the Signature Quarters, LLC conversion without prior written authorization from the factory will VOID THIS WARRANTY IN ITS ENTIRETY.

This Warranty covers only defects in original components supplied by Signature Quarters, LLC which arise from normal use. Warranty does not apply and is specifically disclaimed if the trailer has been subject to accident, abuse, misapplication, misuse, corrosion, neglect, water damage, humidity damage or has been repaired or altered without prior written consent of Signature Quarters, LLC.

Under this Warranty, Signature Quarters, LLC will not be responsible for any incidental, consequential or any other economic damages or contingent liabilities incurred as a result of any defect including, but not limited to loss of time, inconvenience, loss of use, trailer rental expense, lodging,

meals, other travel costs and/or storage charges. Normal wear items will not be replaced due to wear under this Warranty.

All Warranty repairs and adjustments must be PRE-AUTHORIZED by Signature Quarters, LLC. Any Signature Quarters, LLC conversion found to have defective material or workmanship must be serviced or corrected by an authorized factory representative or by Signature Quarters, LLC. Signature Quarters, LLC will not make reimbursements for any repairs and/or adjustments made without prior written consent by Signature Quarters, LLC.

Signature Quarters, LLC reserves the right to decide if the workmanship or material defect should be serviced at the factory. Signature Quarters, LLC will not allow any reimbursement for transportation to and from the factory or the authorized place of repair and Signature Quarters, LLC shall not be liable for any such costs. When required photos of defective part or parts of the actual part or parts may have to be sent to Signature Quarters, LLC before a warranty claim approval can or will be made. Any part or parts returned for warranty must be pre-paid freight to Signature Quarters, LLC.

THIS WARRANTY IS EXPRESSLY MADE IN LIEU OF ANY AND ALL OTHER WARRANTIES EXPRESSED OR IMPLIED INCLUDING THE WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE AND NO ONE, INCLUDING AN AUTHORIZED SIGNATURE QUARTERS, LLC DEALER, IS AUTHORIZED TO MAKE ANY FURTHER OR ADDITIONAL WARRANTIES ON BEHALF OF SIGNATURE QUARTERS, LLC. ALL OTHER WARRANTIES BEYOND THE DESCRIPTION ON THE FACE OF THIS WARRANTY ARE EXPRESSLY DISCLAIMED.

REQUIRED WARRANTY CLAIM PROCEDURE

1. In order to validate this Warranty, the original copy of the attached signature card, signed by the original purchaser must be postmarked to Signature Quarters, LLC no later than thirty (30) days following the purchase of your Signature Quarters, LLC conversion.
2. Within ten (10) days of discovering a problem with your Signature Quarters, LLC conversion, notify the authorized Signature Quarters dealership by phone or by mail. The dealership will contact Signature Quarters to request a warranty authorization claim number.
3. Signature Quarters, LLC will acknowledge such receipt of claim in writing and will respond to the claim as soon as possible.
4. Any defective part(s) must be sent prepaid freight to Signature Quarters, LLC in order to qualify the claimant for replacement or reimbursement under this Warranty.
5. Signature Quarters, LLC will not reimburse any claimant for any adjustment or repair of your Signature Quarters, LLC conversion without prior written approval by Signature Quarters, LLC.
6. Signature Quarters, LLC may require the claimant deliver conversion to the factory for repair.
7. If you return your trailer for repair to the factory, Signature Quarters LLC will warrant the repair or replacement for ninety (90) days or the remainder of the Warranty period, whichever is longer, from the date of repair.
